TERMS AND CONDITIONS OF OPEN ENROLLMENT AT GOLDEN GATE UNIVERSITY

- Open enrollment registration does not constitute admission to Golden Gate University.
- Students registered in open enrollment status are not eligible for financial aid.
- Students registered in open enrollment status are not eligible to earn a certificate. If you seek a certificate you must file an application
- Open enrollment in graduate courses requires the minimum of a bachelor's degree, which must be declared on the open enrollment form.
- The maximum number of credit hours taken as an open enrollment

- student that may apply to a program upon admission is limited to 12 undergraduate credits and 9 graduate credits.
- Open enrollment students are allowed to choose between credit (pass/ fail or letter grade) and audit.
- Open enrollment students are required to maintain satisfactory academic standing to enroll and to remain enrolled. Evidence of satisfactory academic standing for an undergraduate student is a minimum 2.00 cumulative grade point average, and for a graduate student is a minimum 3.00 cumulative grade point average. Students who fall below this standard will not be permitted to register.
