## **CERTIFICATE OF FINANCES INSTRUCTIONS**

Carefully read these instructions and provide the requested information and financial documentation demonstrating your ability to pay all tuition, fees, and living expenses for the first year of your academic study (two academic terms only) with Golden Gate University (GGU). An I-20 Certificate of Eligibility for Nonimmigrant Student Status will be issued to you once admitted to GGU and financial documents have been verified. GGU is unable to issue an I-20 without financial certification. After you receive your I-20 from GGU, bring the I-20 with the financial documentation to the nearest U.S. Embassy/Consulate to apply for an F-1 Student Visa.

- 2. Attach PDF copies of your financial and other documents and a certified English translation (if applicable)

- Be in English or be accompanied by a certified English translation
- Be on official bank/financial institution letterhead, with bank stamp or bank officer's signature
- Show at least minimum funding required for one academic year and type of currency
- Include the account holder's name (if account is not in student's name, then name on financial document must match name of sponsor in Sponsor Agreement section of the Certificate of Finances Form)
- Financial documents must be less than one-year old at the time of I-20 application

- Loan Letter(s)
